CONSTRUCTION NOTIFICATION WORK IN YOUR NEIGHBORHOOD



PROJECT AREA: NEW HAVEN - WARDS 9,10, 13, AND 14

PROJECT OVERVIEW

As part of the implementation of the City of New Haven Long Term Control Plan, Combined Sewer Overflow (**CSO**) Regulators 012 (Mitchel Drive) and 020 (Quinnipiac Avenue) will be closed and the existing sewers near the regulators will be rehabilitated.

BENEFITS

- Elimination of CSO events to the Mill and Quinnipiac Rivers from Regulators 012 and 020, respectively.
- Restoration of the capacity and extension of the life of the existing sewers being rehabilitated.

IMPACTS

- Bypass pumps and piping are required to temporarily redirect flows around sections being rehabilitated.
- Minor excavations are required at manholes to facilitate the lining of sewers. Deeper excavations are required for portions of the sewer requiring replacement.
- Work at Reg. 020 requires the relocation of a gas main.
- Some traffic impacts and detours are expected in the project work area. Traffic will be guided by signage, police, and/or flagman as per City/State requirements.

TIMING AND COORDINATION

Construction Start: Late Summer 2018 **Duration:** Construction is expected to last approximately 3 months per each location followed by final paving. **Schedule:** Mon-Fri from 9 am to 3 pm. Some activities will require continuous work around the clock. **Due to dynamics of construction schedule, weather and other factors, dates and times are subject to change.*
