Sealed bids will be received at the Office of the Director of Finance and Administration of the Greater New Haven Water Pollution Control Authority located at 260 East Street, New Haven, Connecticut 06511 for the **2023 COLLECTION SYSTEM CLEANING & CCTV INSPECTION PROJECT (SSR 2023-03)** until **10:00 AM on Wednesday, June 28, 2023** at which time and place said bids will be opened publicly or via video conference and read aloud.

The work required by the project consists of providing:

- Cleaning services and closed-circuit television (CCTV) inspection of designated large diameter sanitary sewers (Nominal pipe diameters between 24 and 84 inches - approximately 170,000 linear feet (LF)),
- Cleaning services and CCTV inspection of medium diameter sanitary sewers on an as requested basis (Nominal pipe diameter between 14" and 22" - approximately 40,000 LF),
- Cleaning services and CCTV inspection of small diameter sanitary sewers on an as requested basis (Pipe diameters between 8" and 12" approximately 100,000 LF), and
- 4) Cleaning of the Truman Storage Tank.

The information for Bidders, Proposal, Form of Contract, and Specifications may be examined at the Office of the Construction Administrator at the above address. Anyone submitting a bid for this project must have in their possession a copy of THE GREATER NEW HAVEN WATER POLLUTION CONTROL AUTHORITY STANDARD SPECIFICATIONS dated September 2017. The document can be obtained upon payment of One Hundred Dollars (\$100.00). The plans and a "bid package" containing the Invitation; Proposal; Plans; Special Specifications and Notes can be obtained upon payment of a non-refundable fee of Fifty Dollars (\$50.00).

There will be a non-mandatory **pre-bid meeting** on **Thursday**, **June 8**, **2023 at 10:00 AM** to be hosted by the Greater New Haven Water Pollution Control Authority – Operations Department. All registered Bidders will receive an email in advance with additional pre-bid meeting instructions.

A certified check or bid bond in the amount of **fifteen percent (15%)** of the total bid amount must accompany the bid. Said checks or bid bonds will be returned to the unsuccessful bidders upon Award of the Contract to the selected firm and execution of the Agreement. If any bid is not accompanied by a bid bond or check at the specified time for the bid opening, the incomplete bid will not be read, and this action will constitute automatic rejection of the bid.

The successful bidder will be required to furnish a performance bond and a labor and materials payment bond in the form as attached to the Bid Documents for the amount of the total bid. A certified check cannot be substituted for either bond. The Greater New Haven Water Pollution Control Authority reserves the right to alter quantities and to accept or reject any or all bids or any portion of any bids, for any or no reason, including unavailability of appropriated funds as it may deem to be in its best interests.

All bidders are to note that the award of this Contract is subject to the following conditions and contingencies:

- 1. The approval of such governmental agencies as may be required by law.
- 2. The appropriation of adequate funds by the proper agencies.
