

YALE CAMPUS/TRUMBULL STREET AREA SEWER SEPARATION - PHASE 2

Update June 28th, 2024

Construction for the Sewer Separation Project in the vicinity of Pearl Street, Lincoln Street, Bradley Street, Whitney Avenue and Sachem Street in New Haven will occur through 2024. Once completed, the project will have separated approximately 120 acres of storm water from the sanitary sewer system. This will improve roadway drainage, reduce rainwater flows to the sewage treatment plant and increase the available capacity in the sewer system to reduce combined sewer overflows.

UTILITY RELOCATION WORK TO CONTINUE

PARKING BANS WILL BE POSTED - TOWING OF VEHICLES MAY OCCUR.

TRAFFIC ADVISORY

Work Areas require Temporary Parking Bans. If you will be out of Town, please arrange for someone to move your vehicle if a Parking Ban is posted.

Lane Closures and Detours will be required to create a safe work zone and a safe travel zone for the public.

Please communicate with the on-site police officers and traffic flaggers if you need assistance navigating in/around work areas.

Please drive, bicycle, or walk cautiously and allow extra time to reach your destination.

Tree Protection measures to remain in place until work is completed.

STORM DRAIN CONSTRUCTION AREAS

- **PEARL ST –WORK**

The installation of storm drainage piping/infrastructure is progressing west toward Orange Street. This work will have NO impact to water/sewer usage. Please look out for parking bans. Any disturbances to asphalt/curbing will receive an initial temporary repair. An eventual permanent repair will be provided restoring the site to pre-construction conditions.

Southern Connecticut Gas may be out at the intersection of Pearl and Lincoln to perform utility relocation work.

- **ORANGE ST –WORK**

Frontier may be working on cable splicing.

- **LINCOLN ST - WORK**

RWA may perform test pit/offset of water service on Lincoln St. south of Bradley

Southern Connecticut Gas may be performing utility relocation work.

- **BRADLEY ST - WORK -**

Frontier will be performing cable splicing related to the recently perform duct bank relocation.

RWA may perform relocations and offsets.

- **WHITNEY AV - WORK -**

Frontier will be performing cable splicing related to the recently perform duct bank relocation at the intersection of Whitney and Bradley Street.

RWA may continue work at the intersection of Whitney Ave at Bradley to perform relocations and offsets.

- **SACHEM ST - WORK –**

No work is currently scheduled.

GREEN INFRASTRUCTURE CONSTRUCTION AREAS

- **PROJECT WIDE - INVESTIGATION and LAYOUT CONTINUES -**

Surveyors and Utilities will be marking the pavement to identify proposed work and existing buried utilities. Work to construct the Green Infrastructure has not yet been scheduled.

Green Infrastructure is proposed for areas of Orange St, Humphrey St, Clark St, Eld St, Bradley St, Nash St, Mechanic St, and Winchester Av.

Installation of Temporary Signs to identify the Proposed Bio Swale locations may be installed. These signs will provide contact information for the abutting property owners to learn more about the proposed bio swale.
