SUBMITTED QUESTIONS and REQUESTS FOR INFORMATION/CLARIFICATION:

1. Question: Drawing S-201 – Please confirm the 2" grating over the two trench drains are to be aluminum per Section 05 53 16 and not a heavy-duty cast-iron trench grate.

Response: Heavy duty cast-iron trench grate and frame shall be provided, and shall be H20 rated.

2. Question: Drawing S-203 – The stainless-steel bolt-on angle at the perimeter of the FRP planks is listed as L4x4x3/8. Sections 1 and 3 on Drawing S-208 show this support angle as L6x6x3/8. Please clarify if all the angle to support the 6" FRP plank is to be L6x6x3/8 or L4x4x3/8.

Response: Angle sizes vary to support the FRP planks. Instances where the support spans require more robust members. In lieu of the L6x6x3/8 angle, provide C8x11.5 and L3x3x1/4 for supports.

3. Question: Drawing S-305 – Please confirm the details (size of bearing plate, decking support angle, bridging) are the same details as shown on drawing S-210.

Response: Confirmed. Note that Drawing S-210 Detail 4/5 has been clarified to indicate 2 studs.

4. Question: Drawing M- 401 - Note 4 clarifies the two Harbor Crossing lines will need to be dewatered of sewage prior to the removal of the blind flanges and installation of the new air release valves. If available, please provide an elevation of the chamber or invert of the pipe at both sides of the harbor crossing.

Response: Record Drawings were provided in Addendum No. 2.
